DEATH BENEFITS (In-Line-Of-Duty)

North Carolina State..... \$ 50,000.00
Federal..... \$339,881.00 * FY 16
Rescue Relief Fund..... \$100,000.00 **Administered by the NCAR&EMS**

MONETARY SUPPORT (In-Line-Of-Duty Death (Relief Fund)

10% of average weekly salary. The total amount will not exceed 180 days. Must notify NCAR&EMS within 180 days of death. Application must be made within 210 days. **Administered by the NCAR&EMS.**

DISABILITY INCOME (Relief Fund)

10% of weekly salary when injured in-line-of-duty. Must notify NCAR&EMS within 180 days of injury. Application must be made within 210 days. **Administered by the NCAR&EMS.**

SCHOLARSHIPS

\$975,000.00 per year- *
30.....\$ 2,000.00 scholarships awarded - 2 years
30.....\$ 9,500.00 scholarships awarded - 2 year transfer to 4 year
30.....\$15,000.00 scholarships awarded - 4 years

Applicants must apply by March 31 in the year they graduate from high school or the first year after high school graduation. Parents must be an eligible Rescue or EMS worker. **THE BENEFITS BELOW ARE AVAILABLE TO
“MEMBERS” ONLY
(MEMBERS PAY YEARLY DUES)**

1. Shall be a NCAR&EMS member whose name appears on a roster filed by a department who is affiliated with the NCAR&EMS. Any member who is dismissed from his or her squad for any reason shall immediately forfeit membership in the NCAR&EMS.
2. Retired members must remain a member of the NCAR&EMS and meet one of the following.
 - A. 20 years of service
 1. As eligible rescue or EMS worker.
 - B. Disabled
 1. Six months for in line of duty.
 2. Five years for non duty.

ACCIDENTAL DEATH - *Must be Member*

\$20,000.00/DEATH - Coverage is 24 hours a day. (Administered by the NCAR&EMS.)

ACCIDENTAL DISMEMBERMENT - *Must be Member*

Up to \$20,000.00 - Coverage is 24 hours a day. Administered by the NCAR&EMS.

BENEVOLENT BROTHERHOOD - *Must be Member*

Death Benefit is \$5,000.00 which is payable upon death of a member in the fund. (Benefit increases \$1,000.00 with each increase in membership of 1,000.) Administered by the NCAR&EMS. (Updated May 14, 2016)

MONETARY COMPENSATION - *Must be Member*

\$200.00 Member must show evidence to type of natural or man made catastrophe event or proof of monetary loss. Must have a minimum estimated loss of \$1000.00. Administered by the NCAR&EMS.

NATURAL DEATHS - *Must be Member (must have spouse or dependent)*

\$1,000.00 (Administered by the NCAR&EMS)

SCHOLARSHIP FOR MEMBERS - *Must be Member*
