• Staff Update

-We have one (1) position that has been filled since our last meeting, and (1) that we are temporarily leaving vacant;

EMS Regional Specialist (WRO) – James Caldwell, formerly with Wilkes County EMS started work on September 16th.

Western Regional Administrative Assistant - on hold

• Rules – Rules Taskforce, formed by the EMS Advisory Council is still vetting the rules with stakeholder groups. Based on feedback from the public comment sessions, it was obvious that a Paramedic having to degree was needed, but our implementation of a Paramedic going through a Con. Ed. Program, and coming out with a AEMT was not positive. The Rules Taskforce heard that, and the new recommendation is to allow the individual a Paramedic credential for a 4-year period, in order for them to obtain their degree. They also recommended eliminating the "no more than 50% of class being online". Their next step was to identify stakeholders and meet with them to discuss potential barriers. Implementation of these rules will likely not be implemented until 2022. We have met with NC Community College System, NC Board of Nursing, Kate B. Reynolds Foundation thusfar, with a meeting scheduled for Dec. 10th with Duke Endowment. We still need to schedule meetings with NC Association of County Commissioners/Managers, NC Healthcare Association, NC Medical Board, etc. We are continuing to work through the Taskforce, which Robert Poe is the Chairman. The earliest we would enter into the rulemaking process with these rules is August/November '20. Robert was appointed by Advisory Council as the Chairman of the taskforce, so I will yield to him for any comments. (Comment) Thanks to Robert for taking the time to commit to being the chair, and he was in attendance at all 10 of the public hearings, and did a great job running those meetings.

• Continue to work with Division of Public Health on issues related to the Opioid epidemic. Meeting today with Public Health to attempt to get more funding for EMS to help address the Opioid crisis.

(Share Spreadsheet Ideas)

• Annual EMS Expo – September 27th thru October 2nd . 1,200+ attendees at expo (record). Sold out vendor hall with NHRMC helicopter on display. MEDIC (Mecklenburg EMS) won the Paramedic Competition with the scenario of a shark attack. Next years conference is October 2nd – 7th.

• CAAS GVS 2.0 became effective on July 1, 2019. NFPA 1917 & CAAS GVS 2.0 now both address remount ambulances. NC does not have a standard for remount ambulances until the rule is changed. However, keep in mind that then each state has to adopt rules/statutes to address, if those rules for going to be applicable for that state. For example, in NC, the language in Administrative Code now says that remount ambulances are exempt from this standard. At a minimum, that statement would have to be removed. Currently, there are no Ambulance Standards for remounted ambulances.

• In regards to the current Ambulance standard, please make sure that if you buy a new ambulance that you have the proper paperwork to verify that the truck was built to a standard (either CAAS GVS sticker or NFPA-1917 paperwork). We have encountered some trucks that have no sticker verifying this, and we could not inspect the truck until this issue was resolved. Also, please know that new trucks have to be compliant to the standard without exemptions upon inspection. That doesn't mean it can't have exceptions when it leaves the dealer (i.e. stretcher). If you have questions, please call your respective regional office.

• EMS Personnel are still able to report Provider Violence through their profile in Continuum. We are getting a fair number of submissions through the system now.

• Upcoming EMS Administrator's Conference – March at Hotel Ballast in Wilmington. EMS agencies are encouraged to participate in EMS Administrator's Association. These Conferences are important, as changes are forthcoming in reimbursement as we move through Medicaid Transformation.

• We have participated in a number of meetings with the EMS Administrators and Medicaid regarding the transition in Medicaid that has now been postponed indefinitely. We are actually meeting in Raleigh with them as we speak to help the PHP's understand the franchising requirements, licensing, Medicaid Cost Reporting and the way EMS in NC is run. Yesterday, there was a meeting in Greensboro with the Non-Emergency Brokers to make sure their was an open line of communication. If you are not staying up-to-date on Medicaid Transformation and how it is going to affect ambulance transportation, you need to get involved. If we can assist with getting you connected to the right group, feel free to let us know.

• Data System is being sent out for RFP after the first of the year. ESO is currently the vendor.

NCEM: Terry Foxx, From: Brian Barnes

1. Appreciate the continued support of the Association and its members across the various responses over the past year. It has been an extremely busy few years and we couldn't be more proud and appreciative of the teamwork to meet the needs of the citizens.

2. We were successful in securing a one-time appropriation of \$2.3m for the Search and Rescue Program. This funding was primarily focused on sustaining the swiftwater capability as we spent over \$1.4m purchasing boats and motors for the state sponsored swiftwater rescue teams. We have been able to secure another \$1m one time appropriation this year but are hoping to see a budget deal go through to finally get the reoccurring funds that were identified by the Governor and legislature for the SAR Program. Reoccurring funds are going to be vital to long term program sustainability and strategic planning.

3. We are continuing to work on a Land Search Field Team Leader program to compliment the Land Search Field Team member program. We hope to have this program out this year, the series of busy response seasons has pushing this project out longer than we wanted, but we are working diligently to catch up.

4. The next SERC Meeting will be January 17th at 1000 hrs in Raleigh.

Fire & Rescue Commission Certification Brd: Terry Foxx

The Certification Board meet on June 11, 2019 at Rowan Cabarrus Community College in Salisbury. The agenda was read and approved and reports were heard from the Standing and Ad Hoc Committees. Those Ad Hoc Committee reports included the Computer Based Certification Testing and the rewrite of Chief 101-2020. New business included Several Delivery Agency requests were which were handled, program updates to the NFPA 1001 – Firefighter, 1002 – Driver Operator (EVD), 1072 – Haz Mat and 1407 – Training for Rapid Intervention Crews and requalification options for Instructor Upgrades. At least one investigation was heard and discussed along with some minor cleanup for the TIMS class.

The next meeting was held September 10, 2019 at Kernersville Fire Department. The agenda was read and approved and reports were heard from the Standing and Ad Hoc Committees of Computer Based Certification Testing and Chief 101-2020 rewrite. All the program updates, instructor upgrades, TIMS and Instructor Qualifications were discussed along with the updated course descriptions of the NFPA 1001-2013 to the NFPA 1001-2019 Firefighter Standard updates. New business included Several Delivery Agency requests and the draft use of Blocks courses to deliver the 2019 edition of the firefighter standard.

Election of the Chair and Vice Chair was held with Kevin Gordon remaining as the Chair and Terry Foxx serving as the Vice Chair. The next meeting will be held on December 10, 2019 at 10:00 AM at Kernersville Fire Department.

A special called meeting was held on October 30, 2019 to discuss Option 2 of the changes to the NFPA 1001-2019 edition, course descriptions and FIP numbers for those courses.

The Council was given a presentation by Kimberly Clement on disaster management, mobile hospitals, hurricane preparedness and staffing

McKenzie Beamer had transitioned from EMSC to EMS Project Specialist

OEMS is focusing on provider suicides. According to CDC approximately 37% of EMS personnel suffer from PTSD and have thought of suicide with about 7% actually attempting it..

There is a new third party administrator as York was bought by Sedgewick which will be taking over the administration of the fund.

Funding levels for the fund are good as there have been better loss ratios on claims and funding stabilized.

Fire & Rescue Pension Advisory Brd: Debbie Poe / Gary Whitman No Report.

Stroke Advisory Council: Tom Mitchell / Dr. Hervy Kornegay Jr. Met November 14, 2019 divided into 4 groups: Stroke prevention, stroke care, post stroke, stroke advisory. Forming workgroups to work on such as data, stroke registry, survey, prehospital care.

911 Board: Greg Foster

- ESINet
- As of today, 30 PSAPS (911 Centers) are live on ESINet
- There are 40 active Projects and 51 others approved

- Leaving only 6 in the state that has made no decision at this time. The new State 911 NMAC (Network Management and Assistance Center)

- As of September 19th, The NMAC came on line
- Staff to man it 24/7/365 is currently being hired.

- Due to all staff not being in place yet, the center is manned during the day with folks on call at night.

- The NMAC not only will handle issues with the new ESINet but will also help centers with other issues such as telephone problems, etc. 911 Board Members and Staffing

- There has been a large staff turnover for some time now with board staff members but things seem to getting better.

Last report, applications are being taken for the two board staff regional reps positions and should hired soon to hopefully them back to full staff.

Pro Board performed our reaccreditation site visit in February. NC was reaccredited for Haz Mat Tech, Fire Officer III, FIT and instructor III.

Working on implementing an upgrade to Fire Bridge. Should roll out the upgrade in the fall.

NFA Weekend has been approved for 11/20 - 22, 2020.

Smoke Alarm Saturday extended through the end of year instead of doing it on the 1st Saturday in June (June 6th) due to COVID-19. Will have a virtual kick-off on June 6th through social media outlets.

FEMA AFG-S (Supplemental) grant open for PPE for departments to build program after COVID-19.

NCAREMS Update

Thanks for the opportunity to provide an Agency report, on behalf of the Office of EMS.

I must say that this report is one of the most difficult updates that I have had to provide as Chief of the Office of EMS. As much as we have tried to keep business as normal which would typically be covered in this report, we have had to put the bulk of our day-to-day activities on hold, in order to allow staff to focus on our State Emergency Response Team duties. Therefore, I will try to provide you an update based on the activities of the office.

 The week of March 9th, we began staffing the State Emergency Operations Center for COVID-19. On March 16th, we began staffing a Support Cell to take some of the load off staff in the State EOC. Since that time, we have been staffing the State EOC and the Support Cell 7 days a week. Since April 3rd, staff have been responsible for vetting and grouping of all PPE requests for EMS, Long Term Care, Hospital, Clinics, and all other Healthcare providers. This has been a tremendous undertaking, in addition to the other SERT duties during a crisis. Chuck and I can't thank OEMS staff enough for their time, dedication, flexibility and tireless work during this crisis.

Some of the main items related to COVID-19 that I will share;

- ✓ PPE is still in short supply, but NCEM is beginning to receive some of the PPE that was ordered, which is a help.
- ✓ PPE from the Strategic National Stockpile has been depleted.
- EMS remains as a priority to obtain PPE in Group 1, in addition to EMS providing critical care or critical services (i.e. transport of COVID+ patients to dialysis, etc.)
- ✓ All other EMS fall into Group 2. This guidance is available on prioritization on the DHHS website. <u>https://www.nc.gov/covid19</u>
- ✓ The Department has required us to use stakeholder groups to communicate information. We identified the NC Association of EMS Administrators, and the NC Association of Rescue and EMS as our stakeholder groups. They will have the discretion after reviewing information, to disseminate it to their members. I have been sending information to Joel and Phil Ricks to determine what information to share. Thanks for their help in doing that.
- OEMS has initiated a number of waivers to allow EMS agencies / personnel flexibility to handle this crisis:

- NCGS 131E-158 waived required personnel on an ambulance from two credentialed to one. Must request this waiver through System Administrator to OEMS.
- Six-month extension of EMS credentials expiring March – June (automatic).
- Six-month extension of EMS Instructor credentials expiring March – June (automatic).
- Ed Institutions may request six-month extension on their program approval, if it expires between March – June (must request).
- Students allowed 50% of remaining field/clinical time to be high fidelity simulation.
- Student may count time/skills as a 2nd person on unit. (Cannot be primary caregiver).
- Pending E.O. waive quarterly requirement for peer review for EMS Systems, Specialty Care agencies.
- Pending E.O. waive timeframe to test after completion of course
- Pending E.O. extension to permitting requirements for ambulances
- ✓ OEMS is currently conducting some ambulance permitting inspections utilizing a virtual inspection. To date, we have conducted appro. 64 virtual inspections virtually. This will help ensure that you don't have any billing issues and alleviate the backlog of inspections after the crisis. Thanks to the agencies for allowing us to conduct these type inspections.
- ✓ OEMS could issue a temporary EMS credential for people meeting certain criteria. This must come to OEMS through the EMS System Administrator.
- ✓ Please let us know if you have staffing shortages due to COVID-19, and we will be glad to try to assist you with maintaining adequate personnel.
- ✓ OEMS is also actively involved in the planning for medical surge, LTC outbreaks, and volunteer management.
- Rules We are still working to initiate rulemaking to make changes to NC Administrative Code (13P). These changes will be addressing EMS education, system and trauma. These proposed changes are not addressing the degree requirement for advanced EMS credentials. We are currently working on the fiscal note, with plans to seek approval from the EMS Advisory Council in June and go to Medical Care Commission in August to enter the rulemaking process.

There will be several opportunities to provide input, once the proposed version is put into the process.

- Continue to work with Division of Public Health on issues related to the Opioid epidemic.
- We are working on preparations for 2020 EMS Expo, to be held in Greensboro on October 2nd – 7th. Notification was made this week to presenter's that were accepted for this year, and those presentations that were declined. So far, we have an excellent lineup of speakers and will be focusing some sessions to COVID-19. We will also be looking at changes needed at Expo to ensure the health and safety of attendees in our "new" normal.
- The upcoming EMS Advisory Council Meeting scheduled for May 12th has been moved to June 9th, due to COVID-19. The meeting location has been moved from the Brown Building to the Wright Building on the Dix Campus. We will be evaluating this date in mid-May to determine whether it is safe to have the meeting June 9th, and what restrictions will be implemented to ensure everyone's safety.
- The preliminary rounds of the Paramedic Competition are still scheduled to be held July 10th at select Community Colleges around the state. We will be evaluating this date in mid-May to determine whether it is safe to hold at that time.
- CAAS GVS 2.0 became effective on July 1, 2019. NFPA 1917 & CAAS GVS 2.0 now both address remount ambulances. NC does not have a standard for remount ambulances until the rule is changed. However, keep in mind that each state must adopt rules/statutes to address, if those rules for going to be applicable for that state. For example, in NC, the language in Administrative Code now says that remount ambulances are exempt from this standard. At a minimum, that statement would have to be removed. Currently, there are no Ambulance Standards for remounted ambulances.
- Regarding the current Ambulance standard, please make sure that if you buy a
 new ambulance that you have the proper paperwork to verify that the truck was
 built to a standard (either CAAS GVS sticker or NFPA-1917 paperwork). We
 have encountered some trucks that have no sticker verifying this, and we could
 not inspect the truck until this issue was resolved. Also, please know that new
 trucks must be compliant to the standard without exemptions upon inspection.
 That doesn't mean it can't have exceptions when it leaves the dealer (i.e.
 stretcher). If you have questions, please call your respective regional office.

- EMS Personnel are still able to report Provider Violence through their profile in Continuum. We are getting a fair number of submissions through the system now.
- Upcoming EMS Administrators Conference August 4th 7th at Renaissance Hotel in Asheville. EMS agencies are encouraged to participate in EMS Administrator's Association. These Conferences are important, as changes are forthcoming in reimbursement as we eventually move through Medicaid Transformation.
 - We have participated in several discussions recently involving telemedicine, and how it can be utilized by EMS. If you recall the Medicare Innovation Center released the agencies that will receive the ET-3 monies, which has been delayed now due to the virus. There were 6 agencies in NC that were recipients:
 - Cumberland County: Cape Fear Valley Mobile Integrated Health Care
 - ✓ Forsyth County: Forsyth County Emergency Services
 - ✓ Forsyth County: LifeStar Emergency Services
 - ✓ Forsyth/Rowan County: Nucare Carolina Ambulance
 - ✓ Mecklenburg County: MEDIC
 - ✓ Wake County: Wake County EMS

EMS can perform telemedicine currently, but there is currently no funding mechanism for EMS to be reimbursed for doing telemedicine. However, currently the physician that does the consultative visit via telemedicine can be reimbursed for their services.

• Data System is being sent out for RFP in the coming months. The RFP is currently undergoing legal review. ESO is currently the vendor.

1.5 ARTICLE V: Officers, Governing Bodies, Committees, and Employees

1.5.1.2 Subsection B: Commander and Vice-Commander

The Commander shall be a member of the Association in good standing <u>for a</u> <u>minimum of five years, a North Carolina resident, have physically attended</u> <u>three-fourths (3/4) of the committee and directors meetings in the previous two</u> (2) years, have a valid North Carolina Operators License, and pass a <u>background check or have a certification from the North Carolina Office of</u> <u>Emergency Medical Service (who does background checks).</u> S/he shall not hold any other elective Association or Area office while serving as Commander. The Vice-Commander shall be a member of the Association <u>in</u> good standing <u>for a</u> <u>minimum of five years, a North Carolina resident, have physically attended</u> <u>three-fourths (3/4) of the committee and directors meetings in the previous two</u> (2) years, have a valid North Carolina Operators License, and pass a <u>background check or have a certification from the North Carolina Office of</u> <u>Emergency Medical Service (who does background checks).</u> S/he shall not hold any other elective Association or Area office while serving as Vice-Commander, except as noted in the By-Laws for Interim Vice-Commander.

1.5.6.2 Subsection B: Standing Committee Chairpersons

The Commander and Vice-Commander shall, with the majority approval of the Board of Directors, appoint committee chairpersons, provided that appointed committee chairpersons shall be members of this Association <u>and have attended at</u> <u>least two-thirds (2/3) of committee and directors meetings in the previous two</u> <u>years</u>. All standing committee chairpersons are Appointed Association Officers and are subject to the conditions of the Appointed Association Officers.

1- Accounting System:

We updated the accounting software beginning October 1, 2019. This was a challenging because of timing of it coinciding with the roster time as well. Accounting systems calculate the same but the new system was a bit of change in work flow and navigation, as we had been on the old system for quite some time. Becky and myself particularly have been working through getting used to it and learning this which has caused some back log in reporting but we are up to date and moving forward. This system is called Front Accounting which is open source and allows Doug our IT to be able to make changes to the program as needed, the particular importance of this is the Brotherhood billing which has been integrated better than before with the database and is an easier process for that. If you notice the reports are formatted differently and I hope are easier to read and perhaps understand.

2-Budget -

Attached you will find the proposed budget. There is quite a bit of uncertainty in the economic future and timing for any amount of recovery at the moment. There are also many that are out of work and we at the office are thankful we can work and be paid. Those thoughts in mind I am not recommending pay increase only because of the situation we are facing and that everyone is having to deal with this event across the world. I think all of our staff deserve a staff increase that has we have been able to typically do. I don't know what our funding stream will look like going forward simply because of the effect across the world this is having. I am committed to keeping cost down as much as possible as usual and will look for ways to do that more. Hence why I am looking too keep the budget in line with the current year. We can look as we go forward and amend next years budget as we see how the economic recovery is going and what adverse effects may trickle or flood down to our revenue to evaluate a possible end of year bonus perhaps to add to the salaries if signs are favorable financially. Otherwise we will hopefully be in a better position. Salary increases would equate to an additional \$11,000.00 in the budget proposal if included.

3- Brotherhood -

Unfortunately I need to report that numbers of BH members overall are down to 5500 which will require us to drop the benefit to \$4500.00. Over the last year I have tried to cut/absorb some of the expense of the BH to keep from reducing the benefit while we send letters to everyone removed by departments out of the Brotherhood and encouraging new departments to let the members know of the benefit and that they can be individual members. We budget for a operating assessments which is a dollar per member assessed and we have not done one in many years and it always leads to questions and concerns. I also propose to send a letter out explaining the reason for the assessment to cover operating expenses and to assess \$2 to each member of the BH to assist in building up funds. I have also tried to do some research on if there is or are an insurance policy that could replace this and initially the premium was better than the average \$65

average death paid per year but over time could say that it would stay that was with experience that would ultimately occur. I even asked about if we included the entire association that estimate came back to the tune of \$2 / mo/member which would increase dues by \$12 for every member on top of our \$16. Please share any ideas you may have that I can perhaps run down.

4- Audit / Tax Return for 18-19 everyone should have received a copy of those and I did not many question. We should approve these for the record.

5- Our long time investment financial advisor Jimmy Hare has left Wells Fargo Advisors due to a difference in his thoughts and theres on the way Wells Fargo is handling accounts. Primarily lower value accounts which would shift those from a more personal level to on line interactions. Jimmy was committed to keep those relationships and chose to change companies to Janney Montgomery Scott. The office is still local to Goldsboro and fees would along the same that have been incurred and our holding would remain the same if we chose to move our accounts. It would be my recommendation to do so as Jimmy is very familiar with us and we are familiar with him. He is planning to remain in the financial industry for the foreseeable future and would like to keep our relationship intact. The Relief Fund Board has also reviewed are ok with moving that account as well.

Legislative Update for the North Carolina Association of Rescue & EMS May 1,2020

As the COVID-19 virus continues to plague our great State, I am proud to represent the North Carolina Association of Rescue & EMS as they are in the front-line trenches of this virus war. I have had numerous conversations with legislators outlining the vital role each of our rescue and EMS units play in their communities. Discussions have been held on what the needs of the Rescue and EMS community are and how legislative leadership can help to achieve some of those goals. From discussions concerning protective gear and ensuring that each unit has the necessary PPE, to inquiries about how the North Carolina Association of Rescue & EMS can play a part in the pandemic, Members of the North Carolina House and Senate have endeavored to be sure that our front-line forces are well-equipped to deal with the issues regarding COVID-19. I greatly appreciate the respect that the North Carolina General Assembly has shown to the Association.

It is a very different time in North Carolina as the State struggles to deal with the affects of the COVID-19 virus. Remote committee meetings and legislative sessions will most likely be the new norm in the short-term for the North Carolina General Assembly. The House COVID-19 working groups have been meeting virtually for the last month via WebEx. Adopting to the technology and the challenges faced by working remotely has added an increased difficulty to an already challenging situation.

On April 28 the North Carolina General Assembly returned to Raleigh to begin their 2020 legislative short session. The goal of this week's session was to put together the first of the COVID-19 outbreak relief packages. The initial COVID-19 disaster relief bill was passed out of the House and Senate chambers and will move on to the Governor possibly this weekend. The spending package will be between \$1.2 and \$1.7 billion. It is the intention of both chambers to have ongoing meetings and conversations regarding the needs of the citizens of North Carolina concerning the virus. That is why this bill will be the first of multiple COVID-19 spending packages. Fortunately, North Carolina has about \$3 billion in reserve at this time.

Most of the legislation related to the COVID-19 virus will end on a date certain. Items such as the extension of time to get your car inspected or to pay your taxes will all end on August 1, 2020 according to the proposed legislation. Future COVID-19 related bills will also have time limits on policy changes. Substantive policy issues could be taken up when the legislature returns for their regular short session later this summer, most likely in July.

A few of the issues that will be in the forefront will be how do we conduct elections in the new post-COVID-19 world and how do we open businesses safely. With some congressional primaries still outstanding, there is a major push to have mail-in ballots. This will be hotly contested as the verification process is not considered reliable by some. What will elections look like in November? At this point, it is anybody's guess. Also, look for bills that address how to get money to small businesses and how to better fund rural hospitals as we move forward in the COVID-19 situation.

I have reached out to Members of both bodies to inquire if there is any possibility of finding funds for volunteer rescue and EMS units that are losing their much needed revenue sources since most of those existing sources have been restricted. I will continue to push for volunteer departments to have access to some of these COVID-19 funds that are being spread around in various areas. If there are other areas that we need to make the legislature aware of, please let me know.

It is my deep honor and pleasure to represent the North Carolina Association of Rescue EMS. Thank you for all that you do to keep the citizens of North Carolina safe.
