OSFM: Brian Wade

- -The Albemarle building is currently open, however most of our staff is working remote. -Blue Cross/Blue Shield provided \$500,000 that has been distributed as \$5,000 grants to 100
- -High Angle School, Extrication School and the NFA Weekend have all been cancelled due to COVID-19.
- -The Rescue Grant is currently open (until October 1). Notifications will be made on December 15.
 -NFPA 1006 will be released in 2021 and we will begin working on the program re-write.
 -Welcome Lance Foulk & Mark Rutherford to Training Staff.

OEMS: Tom Mitchell

Thanks for the opportunity to provide an Agency report, on behalf of the Office of EMS. We appreciate the ongoing relationship with the Association and look forward to being a part of the activities of the association in the future.

I want to start by saving this report continues to reflect updates, as the Office of EMS is heavily involved in the state's response to COVID-19. As much as we have tried to keep business as normal which would typically be covered in this report, we have had to put the bulk of our day-today activities on hold, in order to allow staff to focus on our State Emergency Response Team duties. Therefore, I will try to provide you an update based on the activities of the office.

• We have had staff engaged in the State Emergency Operations Center for COVID-19, since the week of March 9th. We have scaled back a lot of staff involved in COVID response, to allow them to focus on their normal duties. We do still have staff running the NC Healthcare Supply warehouse, which is in Mocksville, and some staff working on staffing shortages for LTC, ACH, etc. Part-Time & Full-Time employees have been hired to process PPE requests at the warehouse. There are efforts underway to hire a Warehouse Manager to allow additional personnel to return to their normal duties. That position closed vesterday (Friday), so applications will be reviewed soon.

- •The Department is still utilizing stakeholder groups to communicate information related to the COVID response. We have identified the NC Association of EMS Administrators, and the NC Association of Rescue and EMS as our stakeholder groups. They will have the discretion after reviewing information, to disseminate it to their members. I have been sending information to Joel and Phil Ricks to determine what information to share. Thanks for their help in doing that.
- •OEMS still has several waivers in effect to allow EMS agencies / personnel flexibility to handle this crisis;

oNCGS 131E-158 waived required personnel on an ambulance from two credentialed to one. Must request this waiver through System Administrator to OEMS.

oSix-month extension of EMS credentials expiring March – December (automatic).

oSix-month extension of EMS Instructor credentials expiring March – December (automatic). oEd Institutions may request six-month extension on their program approval, if it expires between March – December (must request).

oStudents allowed 50% of remaining field/clinical time to be high fidelity simulation. oStudent may count time/skills as a 2nd person on unit. (Cannot be primary caregiver).

Please let us know if you have staffing shortages due to COVID-19, and we will be glad to try to assist you with maintaining adequate personnel. OEMS is also actively involved in the planning for medical surge, LTC outbreaks, and volunteer management.

- •Rules We are still working to initiate rulemaking to make changes to NC Administrative Code (13P). These changes will be addressing EMS education, system and trauma. These proposed changes are not addressing the degree requirement for advanced EMS credentials. We are currently working on the fiscal note, with plans to go to Medical Care Commission in November. Approval was provided by the EMS Advisory Council in August at their virtual meeting. There will be several opportunities to provide input, once the proposed version is put into the process.
- •Continue to work with Division of Public Health on issues related to the Opioid epidemic.
- •As you are aware, we cancelled the 2020 EMS Expo, due to concerns with COVID. We also used this as an opportunity to evaluate our future conferences. We worked with the Sheraton Greensboro to move the dates of our upcoming conferences. The dates for our upcoming conferences are;

We are finalizing speakers for the 2021 EMS Expo. Most speakers that were approved for the 2020 Expo will be speakers for the 2021 Expo. We will also be looking at changes needed at Expo to ensure the health and safety of attendees in our "new" normal.

- •The preliminary rounds of the Paramedic Competition will be held in early 2021 to account for the date change of EMS Expo. Information will be sent out regarding the dates, locations, etc. as we get closer.
- •We will hold a Medical Director's Workshop (Virtual) on Tuesday October 6th from 10:45am 12:00pm to allow medical directors to meet their annual requirement. Information has been sent to all EMS System Administrators and Medical Directors. If you have any questions or did not receive the notification, please contact your Regional OEMS office or let us know.

- •CAAS GVS 2.0 became effective on July 1, 2019. NFPA 1917 is currently undergoing a revision to their standard that addresses both new & remount ambulances. The new standard will not be effective until md-2021. The current NFPA-1917 & CAAS GVS 2.0 now both address remount ambulances. Currently, there are no Ambulance Standards for remounted ambulances in North Carolina.
- •Regarding the current Ambulance standard, please make sure that if you buy a new ambulance that you have the proper paperwork to verify that the truck was built to a standard (either CAAS GVS sticker or NFPA-1917 paperwork). We have encountered some trucks that have no sticker verifying this, and we could not inspect the truck until this issue was resolved. Also, please know that new trucks must be compliant to the standard without exemptions upon inspection. That doesn't mean it can't have exceptions when it leaves the dealer (i.e. stretcher). If you have questions, please call your respective regional office.
- •EMS Personnel are still able to report Provider Violence through their profile in Continuum. We are getting a fair number of submissions through the system now.

North Carolina Association of Rescue and EMS, Inc. Board of Directors Meeting September 12, 2020

2020 has been an unusual year and has impacted almost every aspect of our daily lives. The same holds true for the 2020 legislative short session of the North Carolina General Assembly. This year's "short session" and two mini sessions were focused around issues relating to COVID-19, primarily health care, education, economic support and the continuity of state operations. The majority of select and interim legislative committee meetings leading up to the short session were held virtually. For the first time ever in the State's history, House members were allowed to cast a vote without having to be physically present. In committee meetings they were allowed to vote virtually, and during legislative sessions, they were able to have the majority or minority leader vote on their behalf via proxy. This, too, is the first time that North Carolina did not have a new biennium budget. With a few exceptions, we are still operating on the 2017-2018 budget that was passed two years ago. You will remember that Governor Cooper vetoed last year's proposed budget and a new budget was not negotiated during this year's short session. This is also the first year that legislators have not known how much money was available to be spent by the State before the July 1 deadline. This is due to the fact that the personal income tax deadline was moved from April 15 to July 15. Even as late as August, revenue projections were still not fully known for budgeting purposes. And finally, this is the first session where the North Carolina legislature has held meetings and session during a pandemic. Thanks to leadership, technology and dedicated staffers, the North Carolina General Assembly was able to conduct business in as a near-to-normal situation as possible in very abnormal circumstances. This has indeed been a year of firsts.

There were several items of interest during this year's legislative short session. The top of the list would be in the area of COVID-19 funding. It was of paramount importance to legislators that all of our first responders have adequate personal protective gear during this crisis. On several occasions, Joel and I reached out to both departments and members of the General Assembly to assess needs as well as to be sure that funding and safety equipment was available to all of our rescue and EMS units across the State. This will be an ongoing issue as COVID-19 continues.

We also carefully monitored the changes in unemployment insurance funding that have occurred. With record-high unemployment and the increase in payments from both the federal and state, we have endeavored to keep the Association updated on all of the changes that have taken place during the pandemic.

Although COVID-19 continues to be a taxing element on our society, some opportunity does exist. There are numerous grants that may be applied for and obtained because of the free-flowing COVID-19 money. Both the North Carolina General Assembly and the federal government have been funding grants at near-record levels. We have been monitoring these grants to be sure that you have every opportunity to take advantage of these funds.

Moving forward, it needs to be decided what issues will be most important to the Association in the upcoming 2021-2022 legislative session. It is my hope that the Association will come up with this legislative agenda in the near future so that we can begin working on the gameplan as soon as the November elections are complete. As always, thank you for the opportunity to represent the North Carolina Association of Rescue and EMS, Inc. before the North Carolina General Assembly. I look forward to a successful year in 2021.

1.5 ARTICLE V: Officers, Governing Bodies, Committees, and Employees

1.5.1.2 Subsection B: Commander and Vice-Commander

The Commander shall be a member of the Association in good standing for a minimum of five years, a North Carolina resident, have physically attended three-fourths (3/4) of the directors meetings in the previous two (2) years, have a valid North Carolina Operators License, and pass a background check or have a certification from the North Carolina Office of Emergency Medical Service (who does background checks). S/he shall not hold any other elective Association or Area office while serving as Commander. The Vice-Commander shall be a member of the Association in good standing for a minimum of five years, a North Carolina resident, have physically attended three-fourths (3/4) of the directors meetings in the previous two (2) years, have a valid North Carolina Operators License, and pass a background check or have a certification from the North Carolina Office of Emergency Medical Service (who does background checks). S/he shall not hold any other elective Association or Area office while serving as Vice-Commander, except as noted in the By-Laws for Interim Vice-Commander.

1.5.6.2 Subsection B: Standing Committee Chairpersons

The Commander and Vice-Commander shall, with the majority approval of the Board of Directors, appoint committee chairpersons, provided that appointed committee chairpersons shall be members of this Association, and have attended at least two-thirds (2/3) of committee and directors meetings in the previous two years. All standing committee chairpersons are Appointed Association Officers and are subject to the conditions of the Appointed Association Officers.
