OSFM: Brian Wade

OEMS: Tom Mitchell

EMS medication treatment grant for EMS and the opioid issue. It is going through Department of Mental Health. This will help to put someone with an overdose in contact with treatment or if that is delayed then EMS can administer saboxone so they can keep from overdosing before they can get in to treatment. The money will help to expand it from 2 to 10 programs.

Planing for EMS expos 2023 April 28- May 3 Greensboro.

A new website has been created to pull all their different websites together in to one for OEMS/DHHS.

New NCCEP protocols are to come out October 15 and implement January 15.

CAS version 3 was adopted this year. New ambulances will have to built to this standard after July 01. They have seen that some trucks have been delivered with those standards marked on the sticker but then upon inspection some equipment such as a back up camera may have not been installed. OEMS will temporary permit those until those items can be corrected. Please contact the office and they will be glad to assist to make sure they prior to delivery the standards are met. Staff will assist with questions.

Working to allow more access for agencies to be able to get data back out of OEMS system.

-Scott Zander is Search and Rescue Coordinator

- -Search and Rescue Rules are open for comment until October 15 and will take effect in December. There will be advisory teams for the different disciplines.
- -Disaster medical is being incorporated in to the program as well.
- -SHP was approved for a new helicopter and will be incorporated in when it is up to speed on search and rescue and be hoist equipped.
- -USAR, Swiftwater, HART programs have smart phones deployed for them to be able to utilize and collect data for those to help with recovery and statistic. The other programs will be included in data collection as well

Treasurer's Office: David Starling

- -Actuary study will be coming out later this year.
- They have seen increases in all areas in the retirements systems division.
- Looking to be able to help to automate more and have the departments on line where they can manage there documents there. 35% are participating at this time and they are looking to increase that.
- Significant increases in retirement requests across the retirement system. Also increase in buy back requests.
- Deaths have increased by 30-40% across all plans. They are working to process as quickly as possible.
- Reminder to designate beneficiaries on your NC retirement plans accordingly. Be sure if you have multiple plans there that those beneficiaries are named on all.
- Increasing communications through updating website and mailing letters. Such as contacting members that are 55 and have the years to be able to retire. Also to get up with those that have an account that is inactive. A updated newsletter should be coming out as well.

NC 911 Board Update September 10, 2021

At the August 26th, 2022 meeting of the NC 911 board, we voted to approve approximately 13.7 million dollars in grants which includes the replacement or renovation/relocation of two of the counties 911 centers. - These grant aware announcements are currently being made.

The Board also voted on a second grant cycle for 2023 which will open in October of this year and to offer another Priority One Collaboration Grant of \$5,000,000.00 which focuses on collaboration of PSAPs in the following areas:

• Consolidation of two or more primary 911 centers among contiguous or regional jurisdictions where economies of scale and cost savings efficiencies may be realized. This may include bricks and mortar

projects, radio communications, and CAD to CAD. (Not to include transfer of 911 calls between primary PSAPs.)

- Consolidation studies.
- Primary to primary backup capabilities. Creation of backup capabilities at a current primary PSAPremoving the standalone backup. (Logical network backup versus a physical backup.)
- Radio communications consolidation for dispatching capabilities to establish a single primary answering point with more than one dispatch center in a jurisdiction.

The N.C. 911 Board's Next Generation 911 project has earned awards from two national groups recognizing

innovation and leadership in utilizing IP infrastructure and geospatial data to improve the accuracy and reliability of emergency calling. NASCIO Enterprise IT Management Initiative award and the NSGIC Geospatial
