#### NCEM:

Tied in with the legislation in Session Law 2014-27 for firefighter background checks, the General Assembly formalized the State Urban Search and Rescue program. The legislation also opens the door for potential funding in the future for specialized rescue.

There's a good bit of training coming up;

We'll be offering a Swiftwater Boat Operator class in Morganton August 25-29, with another Basic and Advanced course and 2 Water Rescue Logistics/Outboard Maintenance courses in September and October.

There will be 2 USAR courses in October in Charlotte. The 10 day Structural Collapse Technician course will be held October 20-29 and a Heavy Equipment and Rigging Specialist course will be held October 18-21.

The DuPont Rescue Experience will be held again in Henderson County, November 7-9. During the exercise we will be offering a Mountain and Wilderness Rigging course. And we'll be offering the the winter/alpine operations course again in February.

### VIPER Update/Grant Update

- ☑ All VIPER sites are operating on the P25 network.
  - o Training of operators
  - o Understanding for users is being provided regarding the new UPPER CASE channel zones.
- Equipping all permitted EMS vehicles with VIPER mobile radios. Currently, we have successfully awarded 230 Viper mobile radios to 66 different agencies throughout the state. The second round of grant awards will be released shortly. We are considering adopting an "application" process to improve efficiency in awarding this equipment.
- M Lower vs. UPPER case identifiers
- "Second Touch" for hospitals efforts are underway to provide a "second touch" for hospital VIPER radios to remove the older VIPER channels and make the radio "home" to the new UPPER CASE viper channel.
- First Net has been to NC Connect –is a 2 year project/plan. The grant was transferred to ICS. This is a cloud based application.

#### **Healthcare Preparedness**

## National Mobile Disaster Hospital

- On April 28<sup>th</sup>, 21 tornadoes plowed through Mississippi.
- One EF4 tornado was confirmed to have touched down in Louisville, MS.
- 1,119 homes were destroyed.
- 2.390 families were affected.
- Mississippi EMA requested portions of the MDH to augment medical capabilities in Louisville, due to the destruction of Louisville Medical Center.
- N.C. SMRS, MDH Staff, MCT Overhead Team, and NCBM Logistics Support Team responded to Louisville, MS to work with MS EMA to put staff of Louisville Medical Center back to work, until their facility can be rebuilt.
- This portion of the Mobile Disaster Hospital is expected to remain in Louisville, MS for 12 to 18 months while the Medical Center is being rebuilt.
- Thanks to the SMRS, NCEM, Dr. Lew Stringer, NCBM, MCT, and others for a successful deployment.

## **Ongoing OEMS Initiatives**

Redesign of EMS Patches - Committee will be meeting in the next few weeks, to develop opportunities for submission of ideas.

Suggestions will be accepted until September 15<sup>th</sup>.

Winners will be announced during Banquet @ EM Today on October 7<sup>th</sup>. Paramedic, Medical Responder, EMT, Intermediate.

- Interest has been expressed by the NCEMSA Executive Committee to look at another State Ambulance Contract.
- This would be entirely different than the previous Ambulance Contract, similar to the Florida Sheriff's Association Contract.
- Stakeholders will be brought to the table to assist in developing this document with State Purchasing and Contract.

#### **RULES UPDATE**

- Task Force Chair will present the final "Draft" version to the Advisory Council at their August 12th meeting.
- The Medical Care Commission meets in September, we hope to present and receive approval to continue with rulemaking.
- This timeline should allow rules to become effective between April 1<sup>st</sup> and July 1, 2015.

Next rule revision is underway to address Community Paramedic Programs. We anticipate these rules to be ready for review by the Advisory Council by November '14 meeting.

#### Legislative Update

#### Senate Bill 797

- Governor McCrory Signs Law Requiring 911 Center Backup Plans
- Signed into law on July 9<sup>th</sup>
- Every 911 center in NC will be required to have a backup call response plan.
- Of the 127 PSAPs in North Carolina, only 26 have backup plans in place.
- PSAPS have until July 1, 2016 to comply with the new law.

#### Senate Bill 761

• Governor McCroy signs into law 7/10/14 – Military Training and past experience converted into College credit.

- Instructs the UNC and NC Comm. College systems to develop programs that will convert
  military training into college credits and the state's licensure boards into professional
  certifications and licenses.
- Information will be discussed to determine impact on EMS.

## **State Treasurers' Office:**

David Starling, NC Treasurers Office, NC Fire / Rescue Pension Fund

- The Fire & Rescue Pension have been reviewed by NCGA, PED, Treasurer Office Staff, IT, Buck Consultants and others over the last 18+ months.
- Current financial status of the Fund as of June 30, 2014
  - Last Actuary evaluation.
  - 40000 Members of the Pension Fund
  - 12000 Retired members
  - Assets of \$318 Million
  - Funding Ratio just above 80%
- Legislative changes from HB 1034
  - All members who have reached 55 and 20 years of service can receive their pension, so
    those that may still have been compensated by a fire rescue agency would be able to
    receive the benefit starting Oct 1, 2014.
- Operation Update
  - Receiving Contributions are heavy at the beginning of the year during the first quarter and they are working changes to help them better handle that workload in the beginning of the year.
  - Roster have been received in a timely fashion by the Association
  - In the process of selecting a new pension fund coordinator and working to get staffing back up to proper levels.
  - F/R Pension was added to the Orbit system but not fully built out, but are currently working to write the program for that.
  - Review of the NCGA Program Evaluation Report.
  - Working to communicate better with everyone through their website and other means.

- The Certification Board has met twice since our last directors meeting.
- The Policy and Procedures Manual has been reviewed for a couple of clarifications that were needed.
- Currently the TR Rewrites are ongoing and will be back to OSFM staff by September 30, 2014.

- Mr. Bob Bailey presented the Outstanding Leadership Award to Jesse Lee "Tony" Seamon, Jr. in grateful appreciation for his superior leadership qualities and 43 years of dedication to the State EMS Advisory Council. Mr. Seamon recently passed away, and the award was presented to his wife, Mrs. Judy Seamon.
- On behalf of the Disciplinary Committee, Dr. Roy Alson presented a plaque to Ms. Kimberly Sides in appreciation and honor for her 30 years of devoted service to EMS and with special recognition of her successful efforts to establish the EMS Chemical Dependence Program.
- OEMS is working with shareholders and stakeholders to develop a Community Paramedicine curriculum and various other education projects.
- State Medical Director Dr. Winslow gave a report on Senate Bill 20 which encourages the use of Naloxone for lay personnel which also expanded the access of Naloxone to pre-hospital personnel. In working with Dr. Kanoff, the OEMS staff and Dr. Kirby from the NC Medical Board, we have expanded the scope of practice for medical responders to use intranasal Naloxone. Also, law enforcement officers may carry and use this as long as it's done under the supervision, education and protocols all approved by the county medical director.
- The 41st Emergency Medicine Today conference will be held in Greensboro on October 4 8
- The Rules Task Force that was appointed by Chairman Previer has held public comment meetings and has been very busy. We are scheduled to make a full report to the Advisory Council at the August meeting which is Tuesday

- The training and standards committee met in Goldsboro on Saturday, April 5.
- Brian Barnes, SAR Coordinator with NC Emergency Management was on hand to discuss the
  request to implement a NC Alpine & Mountaineering Standard. A draft copy of the propose
  standard was discussed and approved by the Board to move forward. Currently training
  curriculum is being developed, potential dates for training being worked out and

implementation is being scheduled for January 1, 2015. This will allow use of the Rescue Grant for purchase of equipment if need be. A copy of the approved standard will be available for review beginning September 1, 2014. NO INSPECTIONS for this will be done until after January 2015.

- The REMS class will be held in March 2015 and the Graduate School will be held sometime in April 2015.
- All of the standards will be reviewed for clarity, consistency, additions and deletions and these
  revisions will become effective on January 1, 2015. It should be noted that no additions that
  will cause purchasing of additional equipment are expected
